- 1. No Debt current, as all bills are paid when they fall due.
- 2. Budget is on track no overspends.

Item 2. Dunes meeting.

Salient points from our meeting.

- 1. Water Usage bill. It was agreed that Dunes is responsible for the water usage which averages to \$240.00 per month. The Club is responsible for the balance of the water and sewerage invoice.
- 2. The Liquor License will be a contra deal. Where Dunes will donate vouchers equal to the amount of the of the Liquor Lic fee.
- 3. The Current Service Agreement has Monthly increase starting the 1st of September 2024. Being the third year of the Agreement.
- 4. The Club is responsible for cleaning all common areas of the Club and the Sunset room. Dunes is responsible for all other areas: Lighthouse room, Bar and Kitchen. Dunes requires a copy of the Caretakers job description, to ensure no duplication occurs.
- 5. Dunes is looking at relocating the walk-in fridge from the old Gym to the top storeroom. Dunes request the Club to look at if there are any grants to help in this. Dunes will relinquish this area as a contra for helping with this project.
- 6. Dunes will be exercising its option for a further 3 years in April 2025 but wishes to negotiate some wording in the schedule.
- 7. The Club is responsible for Council Trade waste invoice as Dune's pays for private waste via JJ Richards.
- 8. Dunes will not be able to close down for any further major works on the building. Council and the Club needs to come up with a plan and include Dunes in those discussions.

ACTION:

Brent & Kate must be part of any discussions held with Council re building works in the future.

Item 3. Donation Seagull Surf Boat.

The Club will be in receipt of a substantial donation to cover the cost of 3-year-old Surf Boat to replace the Freemason boat. It has been a joint effort to source this boat from my old Club South Maroubra, subject to inspection from Mick Crowe, who has approved the purchase.

The Club has received the Membership Support Sponsorship funds for the first of a 3 year agreement. A huge thank you to Matt Keys and Mark Cooper from Bendigo Bank.

The Club has set up a Special Events Account with Bendigo Bank Wyong. This account is used for spending against an approved budget.

e.g. IRB Gold Coast Trip which has raised over \$10,000 in cash and \$3,000 of in-kind donations. These funds will be transferred into the Special Events Account and funds will be paid out against the budgeted items, utilising a Debit Card. Which will be held by the Director of Finance or their nominee.

This account will only have \$1.00 in the account when it is not in usage.

In October the Club will be moving its 100 account and Grants account over to Bendigo.

In November the Club will move the Working Account over to Bendigo.

The Investment will stay at the Greater until it matures.
