## \*\* IMPORTANT PRE-COURSE REQUIREMENT- Unique Student Identifier (USI) \*\*

From 1st January 2016, Surf Life Saving NSW can be prevented from issuing students with a Nationally Recognised VET qualification or Statement of Attainment when they complete the course if they do not have a Unique Student Identifier (USI).

**Please ensure that all participants bring their USI to the course** as they will need to include this on their Training Enrolment Form.
