

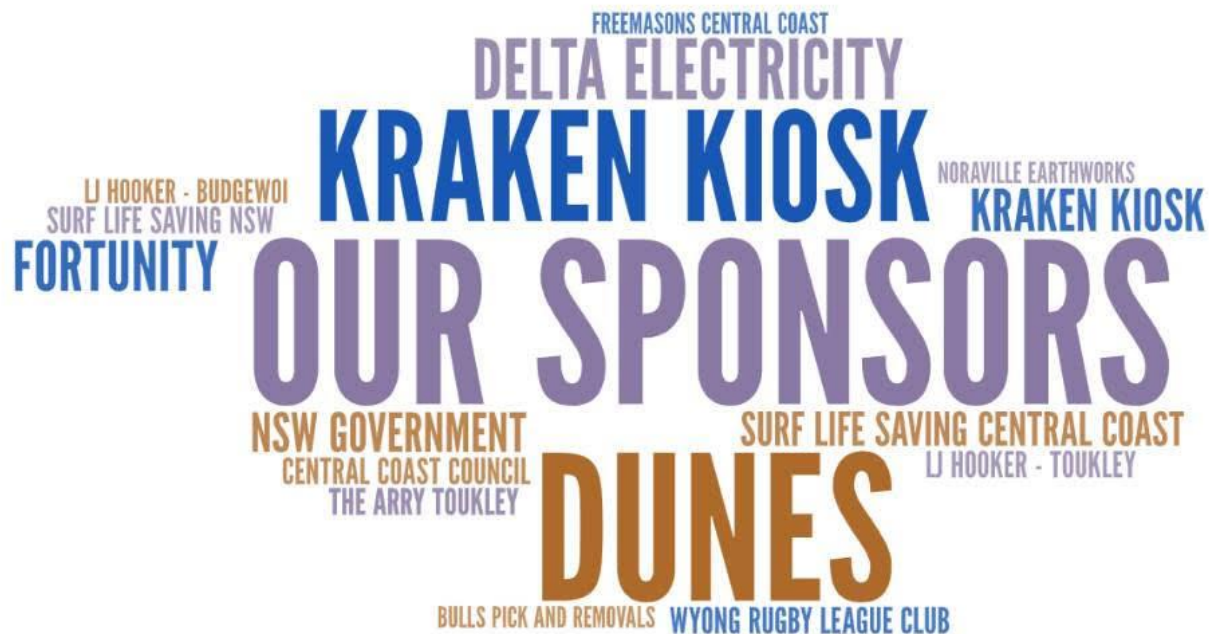

PRESIDENTS REPORT

Presidents annual report 2020/21

With the continued spectre of Covid as a backdrop to our activities, this season can be described as one of change, adaption and innovation. As always, our volunteers have met the challenge and continued to protect the public and maintain a community presence, whilst embracing and working hard to create the new normal.

This season Soldiers Beach SLSC has embraced the use of technology, be it data storage and sharing, enabling online committee function and dissemination of information to the membership, application based records for patrols or the extended use of social media platforms for efficient communication.

Additional pre season training for Patrol Captains and Vice Captains has seen a much greater use and understanding of the patrol operations application. This has seen a marked improvement in patrol record efficiency. In addition patrolling members have completed over 6000hrs of volunteer patrols and almost 100 rescues for the season. This season has again been a challenging one for patrolling members and their diligence and dedication must be acknowledged.

The training and education team has implemented its online platforms for course delivery with marked success for Bronze and SRC courses as well as First aid, ART and IRB Crew courses. This season has seen the recruitment of an increased number of adult trainees and the integration into patrols for the award training has provided increased engagement and retention of award members. This small and efficient team continue to deliver skilled lifesavers and bolster patrol numbers.

Junior development and education has been a major part of the activity at Soldiers Beach over the 2020/21 season. Restructuring and the need for additional protocols for attendance recording and social distancing saw a delayed start to the season. This delay was however negated by the success of the junior development program which caters for approximately 50% of our membership. Increased engagement of parents accompanied by a structured and skills focussed training schedule has seen nipper engagement increase tenfold. The Junior Development team, the parents and the coaches are to be congratulated for this success. The junior development programme has been so successful that for the first time in many seasons this skills training is continuing through the off season with board and swim training.

Although down on junior numbers from previous years, our senior competitors have represented Soldiers at all carnivals this season including State & Australian titles. There has been a solid increase in senior participation in both board & ski competitors along with boat crews. This continues to be an engagement tool for the club attracting more patrolling members and encouraging increased participation.

On the administration front, Soldiers has consolidated the major restructure of its commercial operation which has taken place over the last few seasons. The Management Committee has been successful in securing diversified income streams to ensure the continued financial stability of the club into the future. As noted above, the Management Committee has embraced the use of technology using cloud based applications for communications and document sharing and currently runs all of its meetings online. It has undertaken a review of the clubs strategic plan is currently reviewing its constitution and has reviewed and amended

a number of policies to keep pace with the changing needs of the club. One of the most noted success's has been the introduction of a project plan which has been used to great effect, in conjunction with the SLSA Grants Unit to secure a number of grants for the club worth just over \$90,000.00. The administration continues to maintain active lines of communication with club stakeholders including SLSCC, SLSNSW and the local community. Soldiers has actively fostered its relationship with Central Coast Council and continues to work with Council across a number of fields including facilities management, public access and community engagement.

Sadly, this season has seen the passing of a number of our life members. The passing of Cliff Spong, who was responsible for the introduction of the IRB into surf lifesaving will be lamented by many within the surf lifesaving movement along with life members George Barnes , Laurie Smith, club stalwart Richard Fields, John Edwards and Greg Irvine. Vale!

As the club looks forward to next year, there are a number of promising indicators for the continued success of Soldiers Beach SLSC on the back of the 2020/21 season. The club continues to engage and retain members, there is a tenfold increase in nipper participation, the commercial operations of the club continue to support the club operations and there is a renewed interest in club participation by the membership. All of these indicators are positive steps towards a successful season in 2022.

Treasurers annual Report 2020/2021

2020/21 was certainly one of the most challenging the club has faced in its history. The global pandemic of Covid-19 disrupted and severely impacted on our core business of surf life saving as well as the many activities that go into running a club.

Also directly impacting on our partners opportunities to operate was another direct impact on our commitment to reduce our debt. The stop start nature of the economy resulted in the need for widespread operational cost reductions across all areas of our business and activities.

We need to reduce our debt and have a plan in place for the future. We are fortunate our stakeholders and partners are understanding and have allowed us to put in place payment plans.

Our members are fantastic our core activities are conducted in a cost-effective manner, with little or no impact on the club.

We hope to keep our membership fees at the same price, as a small give back to the members for their commitment to the club.

The support from our sponsors, partners, stakeholders and members was exceptional. Due to constant monitoring, and decisive action taken throughout the year and with the continued support of our partners, we finished the 2020/21 with improved Earnings, positive cash flows from operations and significant repayment of our previously incurred debt.

Despite the Covid-19 compromised year our club development and community programs continued to thrive and assist our local community; our programs promote health and educational outcomes including saving lives. As a surf lifesaving club, we should focus on the power of volunteering and sport and the role that it can play in transforming lives. We NEED active members to patrol the beach and support our younger members. Patrolling our beach is not the easiest but it is rewarding.

A strong recruitment and retention program needs to be a priority heading in the future.

Jim Buckton should be commended for his outstanding work as President. Jim has steered the club in a positive and pragmatic way meeting every challenge and always delivering a positive outcome in favour of the members. The members of the committee have all worked hard to deliver in their portfolios and the overall conduct of the club.

Thanks must also go to Gail Rixom she is one of the unsung heroes of our club, she is a fantastic Assistant Treasurer undertaking many tasks in a timely manner and without complaint. I would also like to thank Emma Dennis who does the real work of maintaining our financial position, keeping our books in order, as well as assisting in the servicing of our debtors and creditors. The club would not have been able to function without the outstanding efforts of Emma and Gail.

Lifesaving annual report 2020/21

This season patrols have continued in the same format as last season with six patrols and a roving patrol. This has meant that patrolling members have had a 2 week on 1 week off roster for another season which has been very demanding on our people. Our patrolling members however have met the challenge and continued to protect close on 150,000 visitors to our beach.

During the season patrols have manned our beach for over 6000 hours and performed 98 rescues at the time of this report. Their skills and diligence have resulted in a number of critical rescues where the patients would have most certainly drowned.

Soldiers can be a very challenging beach with its appearance often masking the dangerous conditions. Our team of skilled and dedicated members have played an active role in not only protecting the public but in educating visitors to our beach about the dangers which are not always obvious. The swim between the flags message is at the forefront of this education.

This season, as in the past, our operations have been supported by SLSNSW and SLSA with a number of support mechanisms such as the Beach Safety Equipment Fund and the Club Lifesaving Equipment Grant. These funds this season have provided new radios for patrol operations along with new patrol tents, training manikins, trauma kits and first aid equipment. We have also been supported again this season by the Wyong Rugby Leagues Club Group with our inclusion in their Club Grants program which has enabled us to purchase a new IRB for patrols. We have also been supported by a generous donation from a life member, Brian Koppman of Noraville Earthworks, which has funded the purchase of a surf kit for the installation on a new patrol motor. Our thanks to the generous supporters of Soldiers Beach SLSC. Without this support our patrols would not have the equipment required to protect the community and visitors to Soldiers Beach.

The Lifesaving Team continues to work closely with our Education Team to increase and maintain the skills of our current patrolling members. The integration of Bronze and SRC trainees has been a successful transition and has resulted in an increase in patrolling numbers across the season. This will continue next season as we work towards increasing our patrolling numbers and patrols.

As the season draws to a close, we would like to acknowledge the time and efforts of our patrolling members and congratulate you all on a successful season at Soldiers Beach.

The 2020/21 season has been a busy one for the Education Team. The season started well but the impact and uncertainty regarding COVID-19 pervaded all aspects of the education portfolio. This season has seen the implementation of the new curriculum for the Bronze Medallion (BM) and Surf Rescue Certificates (SRC). It did present some challenges with the team in allocation of days and the new process. Confusion around requirements for trainers also presented challenges which we hope will be resolved by next season. Unfortunately, this season we did not get the required numbers to run a Parent Surf Rescue Certificate (SRC) course. However, we will try again next season and aim to advertise this much earlier so people are able to have the time needed to train for this course.

We continued allocating people to a Patrol from the beginning of the course. Whilst on Patrol the candidates were able to learn as they went from the Patrol members. This enabled the candidates to connect with their Patrol at the start of the course, apply Patrol related activity to the learning and get a better appreciation of the reality of Patrolling as opposed to going onto Patrol at the end of the course and then trying to develop relationships with their Patrol. These relationships are already formed and beginning to embed. The evaluation of this has been positive and we will continue this process.

We had planned to facilitate, train and assess two Bronze Medallion courses and two SRC courses and succeeded in this goal. It was also planned for an IRB Crew course which had commenced mid-April. It is hoped those participating will be able to complete during the off-season. The team also planned for First Aid and an Advanced Resuscitation courses to be held but due to low responses and these were not held. The First Aid Certificates instead were attended at Central Coast Branch. In an effort to increase the numbers of Award holders on Patrols, a Radio Operators Certificate was held. Those who completed this were allocated to Patrols for the remainder of the season and were a great help in being an extra pair of eyes on the beach.

I would like to take this opportunity to thank all those who make themselves available to the Education Team and willingly share their skills and experience with our students. It really adds

to the quality of the courses to have such experience readily available. And a big thank you to all those who have helped with water safety, scenario training, swim and board training.



Note 1. Summary of Significant Accounting Policies

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the *Associations Incorporation Act 2009*, the *Australian Charities and Not-for-profits Commission Act 2012*, the *Charitable Fundraising Act 1991* and associated regulations. The committee has determined that the association is not a reporting entity.

Soldiers Beach Surf Life Saving Club Incorporated is an association registered under the *Associations Incorporations Act 2009* and domiciled in New South Wales.

The financial report is prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

These are special purpose financial statements that have been prepared for the purpose of complying with the *Australian Charities and Not-for-profits Commissions Act 2012* and associated regulations. The Board have determined that the accounting policies adopted are appropriate to meet the needs of the members of the Soldiers Beach Surf Life Saving Club Limited.

These financial statements have been prepared in accordance with the recognition and measurement requirements specified by the Australian Accounting Standards and Interpretations issued by the AASB and the disclosure requirements of AASB 101 'Presentation of Financial Statements'; AASB 107 'Statement of Cash Flows'; AASB 108 'Accounting Policies, Changes in Accounting Estimates and Errors'; AASB 1048 'Interpretations of Standards' as appropriate for not-for-profit oriented entities.

Going Concern

The Executive Committee note that the Club have made significant improvement to ensure that Club improves its financial position with the Club generating a surplus this year of \$71,232. In addition, the Club has improved its cash holdings from \$4,164 last year to \$19,451 at year end. While current liabilities still exceed current assets at year-end, in the previous year this deficit was a difference of \$51,625 however this year this has reduced to a negative position of \$21,837.

The Executive Committee believe that the Association will be able to continue as a going concern with support from its members, the local community, Surf Life Savings Central Coast Incorporated and Central Coast Council. However, uncertainties still exist with respect to the Association collecting its current outstanding receivables and its ability to extend its terms with its creditors and lenders to ensure it can pay its creditors and lenders as and when they fall due.

Accounting Policies

Revenue

Revenue is recognised when it is probable that the economic benefit will flow to the company and the revenue can be reliably measured.

Sale of goods

Sale of goods revenue is recognised at the point of sale, which is when the customer takes receipt of the goods, the risks and rewards are transferred to the customer and there is a valid sales contract. Amounts disclosed as revenue are net of sales returns and discounts.

Revenue (continued)

Membership fees

Revenue from membership fees is recognised at time of receipt.

Grants and donations

Grant & donation income is recognised as revenue when received unless they are designated for a specific purpose, where they are carried forward as prepaid income on the balance sheet.

Interest

Interest revenue is recognised using the effective interest rate method, which for floating rate financial assets is the rate inherent in the instrument.

All revenue is stated net of the amount of goods and services tax (GST).

Inventories

Inventories are measured at the lower of cost and net realisable value.

Buildings

Buildings are measured on the cost basis and are therefore carried at cost less accumulated depreciation and any accumulated impairment losses. In the event that the carrying amount of buildings is greater than its estimated recoverable amount the decrease in value is shown in the profit and loss statement as a revaluation decrease.

Plant and Equipment / Surf Patrol Equipment

Plant and equipment are measured on the cost basis and are therefore carried at cost less accumulated depreciation and any accumulated impairment losses. In the event the carrying amount of plant and equipment is greater than its estimated recoverable amount and impairment losses are recognised in the profit or loss as revaluation decreases if the impairment losses relate to the revalued asset. A formal assessment of recoverable amount is made when impairment indicators are present.

Depreciation

The depreciable amount of all fixed assets, including buildings and capitalised lease assets is depreciated on a straight line or diminishing-value basis over the asset's useful life to the entity commencing from the time the asset is held ready for use. Leasehold improvements are depreciated over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

The depreciation rates used for each class of depreciable asset range between:

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at end of each reporting period.

Plant and Equipment / Surf Patrol Equipment (continued)

Gains and losses on disposals are determined by comparing proceeds with carrying amount. These gains or losses are recognised in profit or loss in the period which they arise. When revalued assets are sold, amounts included in the revaluation reserve relating to that asset are transferred to retained earnings.

Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at-call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within short-term borrowings in current liabilities on the statement of financial position.

Goods and Services Tax

Revenues, expenses and assets recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Tax Office (ATO).

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included in other receivables or payables in the statement of financial position.

Income Tax

As the company is a charitable institution in the terms of subsection 50-5 of the Income Tax Assessment Act 1997, as amended, it is exempt from paying income tax.

Trade and Other Payables

Trade and other payables represent the liabilities for goods and services received by the company during the reporting period that remain unpaid at the end of the reporting period. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.

Comparative Figures

Where required by Accounting Standards, comparative figures have been adjusted to conform with changes in presentation for the current financial year.

Critical Accounting Estimates and Judgements

Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that may have a financial impact on the entity and that are believed to be reasonable under the circumstances.
